A. Professional Statement

As a member of the Patient Reported Outcomes Measurement Information System (PROMIS) Statistical Coordinating Center, I will provide consultation and psychometric support to users of the existing items and developers of new patient-reported outcome instruments. My background in patient-reported outcomes, survey methods, and patient-centered care makes me an ideal fit for this project. I have published 462 peer-reviewed articles, 13 reviews of the literature and 37 book chapters. For the last 17 years I have held the position of professor of medicine in the Department of Medicine at UCLA. I worked full-time as a behavioral scientist in the RAND Health program from 1984 until 1997 and I have been a RAND consultant since starting at UCLA in 1997. I am the principal investigator for the ARHQ-funded CAHPS study (U18 HS016980) and principal investigator for a subcontract to UCLA from the NIH Patient Reported Outcomes Measurement Information System (PROMIS) project. I am also the head of the measurement core for the UCLA/Drew Research Center for Minority Aging Research (RCMAR), a research and mentoring program intended to reduce health disparities for older African American and Latinos by training and mentorship of minority faculty.
